¹ Variable Rate Information: Each variable APR on the Account is calculated by adding together an index and a margin. The applicable margins are shown below. The index is the highest U.S. Prime Rate as published in the "Money Rates" section of the Wall Street Journal (WSJ) on the last publication day of each month. The index for the WSJ on September 19, 2024 was 8.00%.

Standard APR for Purchases and Balance Transfers:

- WSJ + a margin of 5.90%
- WSJ + a margin of 10.90%
- \circ WSJ + a margin of 16.99%
- Standard APR for Cash Advance transactions: • WSJ + a margin of 18.85%

An increase or decrease in the index will cause a corresponding increase or decrease in the variable APRs on the first day of the billing cycle that begins in the same month in which the index is published. An increase in the index means that the Business will pay higher interest charges and have a higher Total Minimum Payment Due. If The Wall Street Journal does not publish the U.S. Prime Rate, or if it changes the definition of the U.S. Prime Rate, the Bank may, at its sole discretion, substitute another index.
